# **HSCF ANNUAL PHOTOGRAPHY AWARDS**

#### **CATEGORIES**

**HUNTING:** Hunting experiences & related activities; hunters in the field.

**HUNTER WITH TROPHY:** Hunters with game.

**OUTDOOR RECREATION:** Outdoor experiences, including fishing, hiking, sporting clays, shooting activities, etc.

**WILDLIFE-BIG GAME:** Big game animals in their natural habitat.

WILDLIFE-BIRDS: Waterfowl, upland birds, land fowl, turkeys, songbirds and any birds in native wild places.

**HUNTING DOGS:** In action or at rest.

**LANDSCAPE:** Terrains, waterscapes, sunsets, moonscapes, stars and more.

**YOUTH:** Outdoor photos taken by those age 17 years or younger.

**BLACK & WHITE:** Outdoor images submitted in a black & white format.

TRADITIONS & CULTURE: People met on adventures, sharing their traditional ways of living.

**PROFESSIONAL:** Taken by an individual who has realized income for their photography in the past.

**FAN FAVORITE:** The most popular photo as selected by a poll of HSCF members.

**BEST IN SHOW:** The overall best photograph, chosen from any category (professional entries are excluded from this category).

#### **ELIGIBILITY & RULES**

The photo contest is open to HSCF members of all ages. All contestants must have been HSCF members when the submitted photograph was taken. The photographer must enter the photograph, not the individual captured in the photograph, with the exception of the "Hunter With Trophy" category. The same image can only be submitted in one category. Any photographs previously entered into any HSCF awards competition may not be re-entered. Photos taken by an individual who has realized income for their photography in the past, may only enter the Professional category. Entries from professional photographers will not be eligible for the Best in Show award. If selected as a winner in the contest, the award will be credited to the photographer and not the subject, with the exception of the "Hunter With Trophy" category. No HSCF member judging the competition may have an entry in the category they are judging. This contest is subject to all applicable federal, state and local laws and regulations. By entering this contest, all participants agree to have met the eligibility requirements as presented.

#### **CONTEST PERIOD**

The photo entered must have been taken between March 1, 2023 and February 28, 2024. All entries must be completed and received in the HSCF office by March 1, 2024.

### **HOW TO ENTER**

To submit photographs, complete the entry form at WeHuntWeGive.org/membership/awards and attach your digital photographs.

## **ENTRY FEE**

\$10 per photograph submitted.

### **ENTRY REQUIREMENTS**

Photographs should be 1 MB or larger; 300 dpi preferred. One photograph entry per submission. Save image as: Category, First Name, Last Name and # of Entry.

# **HSCF ANNUAL PHOTOGRAPHY AWARDS**

#### **JUDGING**

Judging will be conducted by the HSCF Photo Awards Committee. Judging will be based on composition, originality, creativity, and quality of the photograph. Photos are evaluated anonymously, with the name of the photographer not being provided to committee members. The "Fan Favorite" category will be selected from the winner of each category (Professional entries excluded) and judged by HSCF members, with the selection receiving the most votes being chosen as the winner for this category.

# WINNER NOTIFICATION & ACKNOWLEDGEMENT

Award winners of this contest will be recognized at a pre-planned HSCF event. Winners will be notified in advance. Winning photographs will be published in Hunter's Horn magazine and other HSCF media. One person may not win more than one (1) category each year, with the exception of an individual category and Best in Show or an individual category and Fan Favorite.

#### **PRIZES**

The winner of each category will receive an award recognizing their achievement at the annual awards banquet and \$50.00 in Bass Pro Shops/Cabela's gift cards.
